
Our second session took place on 23 November, 2021, where the topic to be discussed was "Responsible Conduct of Research Education Should Include Issues of Race and Gender. Why?"

### Success story: Path2Integrity's role model Prof. Mojib Latif is the new Presidet of the Hamburg Academy of Sciences



He is an internationally recognised meteorologist and oceanographer who became a professor at <u>IFM-GEOMAR</u>, Kiel, Leibniz Institute of Marine Sciences in 2003. He advocates for research integrity and research ethics, being one of the core members of the <u>Path2Integrity community</u>.



### Path2Integrity supports its Polish partners in the mission to raise awareness towards Research Integrity and Ethics

Path2Integrity is on the mission to raise awareness and contribute to enhancing the Research Integrity (RI) culture in Poland by organising various events and meetings in Polish language. This initiative derives from the fact the very scientific term of research integrity is little talked about in Poland, where the European Code of Conduct (ECoC) on RI has only been introduced in 2020.



## Path2Integrity published a new article in its open-access collection in the RIO journal

A new article was published in the Path2Integrity <u>Open Science Collection</u> in the <u>Research Ideas and Outcomes (RIO)</u> Journal. The paper titled "<u>Dataset:</u> <u>Feedback on the Path2Integrity learning cards for research integrity (2020)</u>" is authored by project partners Ina Berg and Prof. Julia Prieß-Buchheit of the <u>Coburg University</u> in Germany.

This dataset is drawn from feedback given by participants, lecturers, and experts on the Path2Integrity learning cards programme for research integrity in 2020. Positive, as well as negative feedback is presented, thus recording what went well, what did not, and what must be improved. The data collected is viewed as crucial for the further development of tools for teaching and learning research integrity, in particular <u>Path2Integrity's learning cards</u>.



#### **Path2Integrity Training for Educators**

Path2Integrity has started the project's Training for Educators (P2ITE) programme, which aims to introduce the specifics of Path2Integrity training materials to educators and high school teachers, as well as to showcase how to coherently use them.

The duration of the training course is 12 hours and it can be divided into two to three days to complete. The first rounds of the training programme took place between 28 to 29 October 2021, while between 3 to 4 November as well as on 11 November 2021, the project carried out three more sessions. Upon completion of the programme, all of the participants will be issued a certificate.
